Göttingen, August 12, 2004

Your Excellency,

the Iranian citizen and member of the Kurdish language group Mr. Ismail Mohammadi has been sentenced to death in July 2003. His alledged membership to the Komala political party is the only indictment of the 38 year old man.

Last year we already appealed to You to pardon Mr. Mohammadi. Mr. Mohammadi is a married man and father of five children and he is not in the least interested in political activities against the legitimate Iranian government.

I would like to point you to the fact that my organisation and I have stood up more than any other Institution in Western Europe for the survival of the threatened Bosnian Moslems. While Europe as a whole stood by watching the then mass murder of 200.000 Bosnian Moslems we supported Bosnia, held the largest demonstration for Bosnia beyond Sarajevo and organised the only congress about the genocide in Bosnia. We have made the Serbian crimes known world-wide, we have published the first documentaries about this awful genocide, we counselled and coordinated the 120 Bosnian clubs in Western Europe.

We have made known the Serbian concentration camps and the murder of 30.000 prisoners, we protested against the rape-camps and in 1993 we erected a symbolic concentration camp in Vienna at the UN-Conference on Human Rights, we handed over to the International Tribunal lists with the names of 1.500 Serbian war criminals and of 25.000 victims and we achieved the conviction of some Serbian war criminals in Germany, etc..

By pointing this out to You I would like to demonstrate, how consequent our Human Rights organisation has been standing up for the haunted of Islamic belief at a time when Your government as well has courageously taken so many measures for the survival of Bosnia. In those years I was interviewed quite often by the Iranian TV on Bosnia.


